FEE SCHEDULE FOR SETUP, STAGING, SHOOT AND WRAP-UP DAYS:

Commercial Filming Permit - \$2,500 per day

Accessory Filming Use Permit - \$1000 per day

Commercial Filming Permit on properties greater than 20 acres – Up to \$10,000 per day (Contact Village Clerk)

INSURANCE REQUIREMENTS:

Certificate of insurance must be provided in accordance with the following minimum insurance requirements: \$1,000,000 Commercial General Liability per occurrence; \$2,000,000 general aggregate;

\$1,000,000 Products and Completed Operations Aggregate, including full Contractual Liability and Aggregate limits per project. Inc. Village of Upper Brookville, all elected and appointed officials, employees and volunteers to be included as Additional Insured per ISO Form CG2026 or equivalent. Copy of Additional Insured Endorsement must be attached to the Certificate of Insurance. Evidence of Workers Compensation and NYS Disability must be provided respectively on the C-105.2 (unless the State Insurance Fund form U-26.3 applies) and DB-120.1 forms.

NEIGHBORS & POLICE DEPARTMENT:

Along with the fees and permit application signed by the property owner, the property owner must notify neighbors and the Muttontown Upper Brookville Police Department (516-696-9900) of the intent to film on their property.
